Yes, this is already public, but is listed as "conceptual only" in both the MOU and Exhibit H of the Development Agreement, Therefore, it is not a final agreement.

So, let's take a different tact.

I would like to request documentation, and email between anyone at the county and:

The State  
The Coliseum Authority  
The FTA  
The ANLBC  
Other county personnel  
Media  
Private citizen

...where the cost of, and/or scheduling of, the 285 pedestrian/transit bridge is discussed. I believe county personnel are very aware the the total cost of this bridge, including design, right of way acquisition, landing areas of both pedestrian and transit components, moving utilities, rebuilding the originating parking deck, etc. is well over \$6-9 million and is probably closer to \$20 million, and headed for a final cost near my \$30 million estimate. I have have studied this in great detail, discussed with experts, and I suspect that the county already knows, about the real cost, and has known this for months.

The purpose of my request is to find out how long Faye DiMassimo and Tim Lee have known about the real cost, while continuing to state publicly that the cost is still \$6-9 million, therefore, I am copying them on this request.
