An Open Records Request for Chairman Lee -

I would like to have any notes, emails, documents, appointment calendars, texts, or any other communication or records concerning Senate Bill 420 - (relating to general provisions applicable to counties, so as to require referendum approval prior to the expenditure of public funds for the establishment of a fixed guide-way transit)

Specifically, I am looking for communications with legislators and/or the Governor or staff concerning this legislation - such as a request to delay signing or vetoing the bill. I am also looking for communication or documentation with other parties where the subject was Senate Bill 420. These other parties could include anyone, such as members of the CCID, BOC, CCDOT, staff, or private citizens or business owners.
