Proposals for the design of the aforementioned project will be received by the **COBB COUNTY**, a political subdivision of the State of Georgia, herein referred to as "**Owner**", at the offices of the **Purchasing Department, 122 Waddell Street NE, Marietta, GA 30060**, until **12:00 Noon** (local time) on **November 10, 2016**. The program name and program number must be shown on the outside of the bid envelope. **No proposals will be accepted after the 12:00 Noon deadline.**

Proposals will be opened at 2:00 PM (local time) on **November 10, 2016**, in the **Purchasing Department, 122 Waddell Street NE, Marietta, GA 30060**.

The Project consists of professional services for the design and engineering of extending sanitary sewers to areas requested by written petition under the Cobb County Sewer Extension Policy. The proposed project includes new sanitary sewers and replacement water lines in and around Audubon Hills subdivision, new sanitary sewers around the Hogan Drive area of Kennesaw Acres subdivision, and new sanitary sewers to decommission Brookstone No. 3 Pump Station. The scope of services will include field survey and data collection, route selection, preparation of preliminary and detailed designs, easement plat preparations, investigation of wetlands and environmental and cultural resources in compliance with Federal requirements, preparation of permit applications, preparation of bid documents, and bid assistance
