### **PUBLIC REVIEW OF COBB COUNTY'S PROGRAM YEAR [PY] 2014 ANNUAL PERFORMANCE REPORT**

A public review meeting will be held at 10:00 a.m. on Wednesday, March 18, 2015 at the Cobb County Board of Commissioners meeting room located at 100 Cherokee Street in Marietta, Georgia to receive comments on the draft of Cobb County's PY2014 Consolidated Annual Performance Evaluation Report [CAPER] for the time period of January 1, 2014 to December 31, 2014. The U.S. Department of Housing and Urban Development [HUD] requires Cobb County to submit an annual report describing its performance using federal, state, local, and private resources to meet priorities and objectives set forth in the County's Consolidated Plan for 2011-2015. This report provides a review of activities carried out under the Community Development Block Grant [CDBG] and Emergency Solutions Grant (ESG) Programs to address the needs of the low and moderate income citizens, the homeless, the elderly and the mentally and/or physically disabled persons in our community. The CAPER also addresses activities carried out by the Georgia Urban County Consortium [GUCC] which consists of Cobb County as the Lead Agency, Cherokee County, the City of Marietta, and the City of Roswell. The GUCC administers HUD's Home Investment Partnerships Act [HOME].

Copies of the PY2014 CAPER will be available for examination and comment by the public beginning Friday, March 6, 2015, at the Cobb County CDBG Program Office located at 121 Haynes Street in Marietta, Georgia. The required public review period begins Friday, March 6, 2015 and ends Monday, March 23, 2015. The deadline for all written comments is Monday, March 23, 2015 by 5 p.m. Eastern Standard Time [EST].
