

**DIRECTIONS**  
**COBB COUNTY SUPERIOR COURT SOUTH**  
**30 WADDELL ST.**  
**MARIETTA, GA 30090-9642**

**TRAVELING I-75 NORTH:** EXIT AT THE FIRST HWY. 120 EXIT(EXIT #263) AND FOLLOW THE SIGNS TO SOUTHERN POLY. THIS WILL CIRCLE YOU BACK OVER THE EXPRESSWAY AND YOU WILL BE HEADED WEST. FOLLOW UNTIL YOU TO REACH THE INTERSECTION WITH U.S. 41 AND AT THAT TRAFFIC LIGHT TURN RIGHT ONTO U.S. 41 (GOING NORTH). STAY ON U.S. 41 UNTIL YOU COME TO THE BIG CHICKEN, AT THAT INTERSECTION, TURN LEFT ONTO ROSWELL ST. ROSWELL ST. WILL GO STRAIGHT TO MARIETTA SQUARE. SHORTLY BEFORE YOU REACH THE SQUARE, YOU WILL SEE THE COURT BUILDINGS ON YOUR RIGHT AND WILL APPROACH AN INTERSECTION WITH A TRAFFIC LIGHT AT WADDELL ST. (ONE BLOCK BEFORE YOU REACH THE SQUARE.) TURN RIGHT ONTO WADDELL ST. AND YOU WILL SEE A SIGN FOR THE JUSTICE CENTER ON YOUR RIGHT.

**TRAVELING I-75 SOUTH:** TAKE THE NORTH MARIETTA PARKWAY EXIT(EXIT #265). THIS IS THE FIRST HWY 120 EXIT AND ALSO SAYS MARIETTA/ROSWELL. TURN RIGHT AT THE END OF THE EXIT RAMP AND CONTINUE ON THE NORTH 120 LOOP CROSSING OVER U.S. 41 AND EVENTUALLY PASSING THE COBB COUNTY POLICE PRECINCT ON THE LEFT. GO THROUGH THE TRAFFIC LIGHT AT CHEROKEE ST.(A ONE WAY STREET HEADING NORTH) AND AT THE NEXT LIGHT, TURN LEFT ONTO CHURCH ST.(A ONE WAY STREET HEADING SOUTH). STAY IN THE LEFT LANE AND FOLLOW CHURCH ST. TO MARIETTA SQUARE. AT THE TRAFFIC LIGHT WITH NORTH PARK SQUARE (SHILLINGS RESTAURANT WILL BE ON THE LEFT CORNER), TURN LEFT. GO TO THE SECOND TRAFFIC LIGHT, THIS WILL BE THE INTERSECTION WITH WADDELL ST. TURN RIGHT ON WADDELL ST. AND THE ENTRANCE TO THE JUSTICE CENTER WILL BE ON YOUR LEFT.

**PARKING:** PARKING WILL BE PROVIDED FOR CLASS PARTICIPANTS IN THE JURY PARKING LOT ON THE CORNER OF WADDELL & DOBBS STREETS IF YOU ARE EITHER PRE-REGISTERED FOR THE CLASS OR HAVE YOUR BROCHURE WITH YOU AS PROOF OF ATTENDANCE.

IF YOU ARE COMING TO THE COURT FROM THE I-75 NORTH DIRECTIONS, ONCE YOU TURN RIGHT ON WADDELL CONTINUE PAST THE ENTRANCE TO THE JUSTICE CENTER AND THE JURY PARKING LOT WILL BE ON YOUR RIGHT (APPROX. 3 BLOCKS). IF YOU ARE COMING TO THE COURT FROM THE I-75 SOUTH DIRECTIONS, WHEN YOU APPROACH THE INTERSECTION WITH WADDELL ST., TURN LEFT AND THE JURY LOT WILL BE ON YOUR RIGHT (APPROX. 2 BLOCKS).
